

Privacy

We at Luna Glamping Inc. ("Luna Glamping") respect your privacy and your rights to control your personal data. Any data we collect from you in accordance with this policy is protected by us. We do not and will not sell your data to third parties. The prime purpose of collecting your data is to improve your experience while shopping on our website. The Privacy Statement explains the personal information we collect from you, either directly or indirectly, and how we use it. Personal information is any information that can be used to identify you or that we can link to you. The Privacy Statement also covers the choices you can make about the data we collect, and how you can control these decisions. It applies to all products and services offered by Luna Glamping. It also applies to any Luna Glamping controlled web sites, as well as other offline interactions, such as attending a Luna Glamping event. Please read this Privacy Statement carefully to understand how Luna Glamping may collect, use and share your personal information. The terms "we", "us" or "Luna Glamping" are each intended as reference to Luna Glamping Inc.

Information We Collect

We may obtain personal information about you from various sources. We may collect this information when you provide it on our site, our social media platforms, our social networking or mobile applications, or at one of our events. When you visit this site, our social media platforms, or our social networking or mobile applications, we may also collect certain information by automated means, using technologies such as cookies, web server logs and web beacons.

Information You Provide

You may choose to provide personal information to us in a number of ways, such as when you participate in an offer or promotion, or when you make a purchase on our site. The types of personal information you may provide to us includes:

- Contact information (such as name, postal address, email address, and mobile or other phone number)
- Age and date of birth
- Gender
- Username and password, nickname/screen name

- Information provided to us by social networks or mobile applications when you visit our social media platforms or use one of our social networking or mobile applications (such as your name, profile picture, likes, location, friend list and other information described when you connect with the social networking application, and your geo-location details when using one of our mobile applications)

How We Use The Information

We may use the information you provide to:

- Send you promotional materials or other communications
- Provide services to you and operate features on our site
- Process your payment and/or gift card transactions
- Create and manage your online account
- Chat with you or respond to your inquiries

- Operate and communicate with you about our social networking or mobile applications
- Operate, evaluate and improve our business (including developing new products and services; enhancing and improving our services; managing our communications; analyzing our products; performing data analytics; and performing accounting, auditing and other internal functions)
- Comply with applicable legal requirements, relevant industry standards and our policies

We also may use the information in other ways for which we provide specific notice at the time of collection. The information collected is necessary for the purposes set forth above. Without this information, you may not be able to take advantage of some of our products or services. Information We Collect by Automated Means When you visit this site or our online advertisements or use one of our social networking or mobile applications, we collect certain information by automated means, using technologies such as cookies, web server logs and web beacons. Cookies, Web Server Logs and Web Beacons Cookies are small text files that websites send to your computer or other Internet-connected device to uniquely identify your browser or to store information or settings in your browser. Your browser may tell you how to be notified when you receive certain types of cookies and how to restrict or disable certain cookies. Please note, however, that without cookies you may not be able to use all of the features of our website. In conjunction with obtaining information through cookies, our web servers may log details such as your operating system type, browser type, domain, and other system settings, as well as the language your system uses and the country and time zone in which your device is located. The web server logs also may record information such as the address of the web page that linked you to our site and the IP address of the device you use to connect to the Internet. To control which web servers collect this information, we may place tags on our web pages called "web beacons." These are computer instructions that link web pages to particular web servers and their cookies.

Third-Party Web Analytics Services

We may use third-party web analytics services on this site, our social media platforms, or our social networking or mobile applications, such as those of Adobe Site Catalyst and/or Google Analytics. The service providers that administer these services use technologies such as cookies, web server logs and web beacons to collect information (such as IP address) and use that information to help us analyze how visitors use the site. You may deactivate the ability of these analytics services to analyze your browsing activities on this site. Information We Share

We do not rent lists, or sell or otherwise disclose personal information we collect about you, except as described here. We may share your personal information with:

- Luna Glamping controlled affiliates and subsidiaries: We share information with Luna Glamping-controlled affiliates and subsidiaries for business purposes such as internal administration, promoting Luna Glamping products and services and providing customers with our Luna Glamping products and services. It is our legitimate interest to share information with these parties for these purposes.
- Service providers who perform services on our behalf based on our instructions. We do not authorize these service providers to use or disclose the information except as necessary to perform services on our behalf or comply with legal requirements. Examples of these service providers include entities that process credit card payments, fulfil orders, and provide web hosting and marketing services.
- In addition, we and our affiliates and other service providers in Canada and the US may disclose information about

to transfer personal information we have about you in the event we sell or transfer all or a portion of our business or assets. Should such a sale or transfer occur, we will use reasonable efforts to direct the transferee to use personal information you have provided to us in a manner that is consistent with our Privacy Policy. Following such a sale or transfer, you may contact the entity to which we transferred your personal information with any inquiries concerning the processing of that information.

Your Rights And Choices

We offer you certain choices in connection with the personal information we collect from you, such as how we use the information and how we communicate with you. To update your preferences, ask us to remove your information from our mailing lists or submit a request, please contact us as specified below.

- Email Opt-Out: You can at any time tell us not to send you marketing communications by email by clicking on the unsubscribe link within the marketing emails you receive from us or by contacting us as indicated below. - Postal Mail Opt-Out: You can ask Luna Glamping Inc. to stop sending you marketing communications by postal mail by following the instructions that may be included in a particular promotion. You also can request that we refrain from sending you promotional postal mail by contacting us as indicated below.
- Social Networking Application Opt-Out: To remove or delete our apps from your social networking account, follow the instructions from the social network.
- Geo-Location Information: When you use one of our mobile applications, you may be asked for your geo-location.

You may choose not to share your geo-location details by adjusting your mobile device's location services settings. - Withdrawing Consent: You may withdraw any consent you previously provided to us, or object at any time on legitimate grounds, to the processing of your personal information. In some circumstances, withdrawing your consent to our use or disclosure of your personal information will mean that you cannot take advantage of some of our products or services.
- Reviewing, Updating and Modifying Personal Information: Subject to applicable law, you have the right to request access to and receive details about the personal information we maintain about you, update and correct inaccuracies in your personal data, and have the information blocked or deleted, as appropriate. The right to access personal information may be limited in some circumstances by local law requirements.
